- 1. Municipal Code Title 20 Parks and Recreation Second Reading

Jon says that there might be a car show and they may need to have an officer to help mitigate traffic or flaggers with orange coats. Dan would like the neighbors to the private property that will be holding the beer garden to be notified of the event due to noise.
