 - i. Gary motions to approve Ordinance No. 782 Animal Control and for the mayor to sign. Julie seconds. All in favor. Motion carried.
 - ii. Gary asks about the park fence at Dot Park, is progressing.
 - iii. Gary asks about start of waterline projects, waiting for materials.

VII. NEW BUSINESS-DISCUSSION ITEM(s)

1. Ordinance No. 783 – Section 2.12.090 of the TOD Municipal Code – Mayor's Salary

- i. motions to approve Ordinance No. 783 Section 2.12.090 of the TOD Municipal Code and for the mayor to sign. – seconds. All in favor. Motion carried.
- ii. Gary expresses reservations about offering insurance. Evan asks where the pay scale came from. Dianne explains that scale is based on the hours the mayor spends in the office. Additional discussion of insurance. Evan asks about the duties of the mayor within the office. Billie asks if other towns pay by the hour. Dianne explains that the hourly pay is to ensure that future mayors will be in the office and accessible to the public.
- iii. Dianne says that there are 3 alternatives
 - a. Insurance paid in full by the mayor, Gary motions, Evan seconds. All in favor. Motion carries. Dianne will rewrite for next meeting.
 - b. Town pays half of mayor's insurance & nothing toward dependents.
 - c. Town pays for insurance after 80 hours for month.
- 2. Interlocal Cooperation Agreement Amendment 2 with Snohomish County Housing and Community Development Urban County Consortium
 - i. Gary motions to approve the Interlocal Cooperation Agreement Amendment 2 with Snohomish County Housing and Community Development and for the mayor to sign. Julie seconds. All in favor. Motion carried.
 - ii. Dianne reads aloud the agreement to better understand the change in the language, must agree to continue to be eligible for grant monies. Federal HUD requirement.
- 3. Remove Neil Comeau as signer on all Coastal Community Bank accounts.
 - i. Julie motions to remove Neil Comeau as signer on all Coastal Community Bank accounts. – Evan seconds. All in favor. Motion carried.
 - ii. Dianne explains that the town had removed Neil, but the bank could not find paperwork.
- 4. Coastal Community Bank ICS (IntraFi Cash Service) FDIC insured.
 - i. Reed motions to approve placing any TOD funds over \$250,000.00 in a Coastal Community Bank ICS account and for the mayor to sign. Julie seconds. All in favor. Motion carried.
 - ii. Dianne explains that IntraFi is a sweep account that will invest \$250,000.00 over the FDIC amount to ensure that all monies are insured. Additional amounts will be swept into IntraFi accounts in \$50,000.00 increments.
- 5. Gary addresses the vandalism in the park and the need for a camera. There was recently a car driving in the park. Dianne informs that the town's insurance will not allow cameras in an area where children gather.
